4.	Total rental fees shall be and may be paid by cash,

5.	Playmakers agree to provide a clean and safe facility. Renter(s) agrees to return facility
	in a clean state or pay a cleaning fee of \$20/hour. Renter(s) also agrees to refrain from

6.	Renter(s) agrees to comply with all applicable city, county, State, and Federal laws and
